Platinum Golf Membership (January - December)

Restricted to Property Owners, Alumni, Social Members and Tenants only

Includes unlimited green fees

- 18-Hole: One Person – one payment of \$1,340 or 12 monthly payments of \$122*¹
- Family—same household *² –one payment of \$2000 or 12 monthly payments of \$180 *¹
- 9- Hole: One Person - \$895 or 12 monthly payments of \$82 *¹
- Family – same household *² - \$1,320 or 12 monthly payments of \$120 *¹

Associate Platinum Membership *³ (January - December)

Includes unlimited green fees and restaurant privileges

- 18-Hole: One Person - \$1,590 or \$299 up front 10 monthly payments of \$139
- Family – same household *² - \$2,215 or \$399 up front 10 monthly payments of \$ 199

Associate Passport Membership *³ (January - December)

Unlimited green fees, restaurant privileges and amenities

- 18-Hole: One Person - \$1,800 or \$299 up front 10 monthly payments of \$166
- Family – same household *² - \$2,400 or \$399 up front 10 monthly payments of \$ 216

Gold Golf Memberships (May – October)

Restricted to Property Owners, Alumni, Social Members and Tenants only.

Includes unlimited green fees

- 18-Hole: One Person – one payment of \$1,060 or \$299 up front 5 monthly payments of \$169 *¹
- Family—same household *² – one payment of \$1,740 or \$399 up front 5 monthly payments of \$299*¹
- 9-Hole: One Person – one payment of \$695 or \$199 up front 5 monthly payments of \$110 *¹
- Family – same household *² - one payment of \$1,150 or \$299 up front 5 monthly payments of \$190 *¹

Associate Gold Membership (May – October)*³

Includes unlimited green fees and restaurant privileges

- 18-Hole: One Person - \$1,340 or \$499 up front 5 monthly payments of \$195
- Family- same household *² - \$1,990 or \$659 up front 5 monthly payments of \$299 *¹
