### ADDITIONAL INFORMATION REGARDING FEES, DUES, MEMBERSHIPS AND PAYMENTS

- Contact the Golf Shop for more detailed information or for questions about the dues and fees for golf at (828) 885-2005
- A family (household) is defined as one or two adults and dependent children under the age of 25, living full time in the same household (can include dependent students who live away during the school term)
- Golf members have priority on club storage, lockers or pull cart storage space
- If you have not completed a handicap form yet or need to change your handicap on file, please see a staff member in the golf shop for the form. All members will automatically be billed for the annual handicap fee of \$45 each at the beginning of the year and all handicap fees are due on 1/31/21.
- A service charge of \$25.00 will be assessed on all returned checks and interest will accrue at 12% APR on all past due accounts
- Should an account fall past due, the member will be charged the daily rate for each day played until the account is brought current
- Dues are considered past due if they are not paid by the end of the month following the due date. (For example: your annual dues billed in January are due on 2/28/21.
- Refunds of annual dues payments will only be made for health reasons or for termination of CFPOA lot/home ownership and will be prorated to a maximum of 50% of the annual dues paid.
